





RESEARCH ACHIEVES RESULTS FOR FAMILIES







% OF CLIENTS HOSPITALIZED

The Family Center was honored to be one of four agencies nationwide chosen by the Pfizer Foundation for a research study to assess our HIV treatment and medication adherence program. Adherence literally saves lives, because taking HIV medication exactly as prescribed is crucial not just to an individual's long-term health, but also affects their ability to care for their children. Our program, funded by Pfizer's ConnectHIV Initiative, used a variety of techniques to improve clients' adherence to prescribed regimens, including individual and group counseling, innovative electronic pill bottles and text messages, and a peer 'buddy system' which linked adherent clients with those needing support.

This study concluded several months ago with findings showing impressive success. Data collected at baseline and after six months showed clients raising their immune functioning with higher CD4 counts, lower viral loads, better HIV knowledge and higher quality of health. We also discovered that after 18 months of receiving our care, fewer clients are hospitalized. These data show that The Family Center's adherence initiative saves lives and keeps parents in good health to care for their children, so fewer children will ever need to ask, "Who will take care of me?"

LIFE'S SWEETEST MOMENTS DON'T CONTAIN SUGAR.

In Bedford Stuyvesant, where our Brooklyn office is located, diabetes rates are one third higher than the city's average. In response to this startling statistic, The Family Center launched B-SWEL, ("Brooklyn —Stay Well, Enjoy Life") as a new initiative to expand our highly effective health support services for people who are diabetic, pre-diabetic or atrisk for diabetes. Diabetes is among the nation's fastest-growing public health threats, and falls disproportionally on minorities and low-income families. B-SWEL, funded by the Office of Minority Health, provides a six-month wellness and lifestyle intervention focused on diet, exercise, and social support, to help pre-diabetics avoid disease progression and diabetics control their illness.

To meet this ambitious goal, The Family Center created a partnership with Community Healthcare Network and the Bedford Stuyvesant YMCA. In the next three years we will screen 1,200 people, and provide in-depth exercise and lifestyle education to help the 300 people at highest risk lower their weight and blood sugar, increase their physical activity, develop healthier eating habits and improve their access to healthy food.

The Family Center knows that the best parts of life have everything to do with family, friends and supportive, loving relationships. B-SWEL's focus on families, food and fitness provides support for our clients to eat well, move more, and live healthier lives – our way of ensuring that families enjoy life's sweetness together.

The Leadership Council, formerly our Junior Board, celebrates the idea of family with a passionate commitment to serve vulnerable New York City families. Members dedicate their energy, resources and advocacy to the children and families receiving services at The Family Center. This amazing group of professionals changed its name in 2010 to better reflect their evolving role at The Family Center, which includes working more closely with our Board of Directors and continuing to raise money for families in need through two major events: BLOOM and Bids for Kids.

The first of these events, our 7th annual BLOOM, was a dinner and luxury silent auction in May. Leadership Council members worked tirelessly to organize BLOOM, securing fantastic auction items and ensuring the evening's success. Their efforts paid off, as they raised over \$75,000 to benefit The Family Center's Just Buddies program, which matches adult mentors with children and youth.

Fresh from BLOOM's blossoming success, the Leadership Council began planning its 2nd annual Bids for Kids in November. Attendees enjoyed hors d'oeuvres and sipped cocktails while having a high-spirited time participating in a live date auction. The event raised over \$20,000.

The Leadership Council not only continues to put the "fun" in Family Center fundraising events, but also members devote themselves to working on behalf of our families in different ways. In October 2010, the group hosted an afternoon bowling party for our mentoring pairs. Leadership Council members also serve as pro-bono public relations consultants, liaisons to Family Center corporate partners, and of course, mentors to children and youth in our programs.

Raising three daughters and living with a lifethreatening illness would be enough for most people. But Family Center Board Member Alantheia Pena is not most people.

Alantheia first came to The Family Center for help with her living will and to make legal guardianship arrangements for her minor daughter. Lucky for us, she stayed for so much more. At our Manhattan office housewarming in early 2008, Alantheia spoke movingly about how The Family Center has touched her life. That same year, our largest private funder, Robin Hood, featured Alantheia's story in its annual report. Shortly thereafter, Alantheia joined our Board of Directors as one of two consumers, keeping up The Family Center's longstanding commitment to consumer participation at every level of agency life - including Board leadership. But Alantheia also stays involved on the front lines of client services: This February, Alantheia recruited a Mary Kaye representative to provide free facials to 15 consumers in our Fit, Fabulous and Fifty group.

All her work here at The Family Center keeps Alantheia plenty busy, but beyond our walls, she is a tireless advocate for families. She runs a health ministry at Friendship Baptist Church in Brooklyn. She currently works with doctors at Montefiore to develop a new Bronx-based program raising awareness about breast cancer. Last August, the New York Times featured Alantheia in a story about breast cancer survivors and reconstructive surgery. "At the end of it," she reflected, "You see some kind of rainbow." Thank you, Alantheia, for all the ways you shine in The Family Center's rainbow.

NOT <u>JUST BUDDIES</u>, BUT "MORETHAN YOU COULD EVER HOPE FOR"





When Sally found inspiration in the movie 'High School Musical,' Jennifer was there to help her find an arts-focused high school.

When Fred graduated 8th grade, Marty attended the ceremony. But when Jerome's mom, a friend to all at The Family Center, passed, John Morro not only attended her funeral, but also was simply present for Jerome. None at The Family Center can forget this act of devotion.

Statistics behind the positive impact of mentoring are staggering: higher test scores, decreased truancy, improved chance of attending higher education and reduced incidence of drug and alcohol abuse —to name but a few. But theses statistics do not show the impact mentoring can have on the volunteer's life.

One of our longest-serving mentors, John Morro, has been a 'Buddy' to Jerome for more than three years. Mentoring Jerome has been a "great experience, much more than I could ever have hoped for when I started." He explains that the experience really allows supporters to understand the challenges people from different backgrounds face, and that he no longer takes his health or blessings for granted. This inherent value prevails, in addition to the fun times the pair has exploring New York City and just hanging out together. The Family Center is thankful to John and all our mentors —you, too, are more than we and our children could ever hope for!

HOLDING FAMILIES TOGETHER: OUR LEGAL LIFELINE



In your late twenties, you work, date, and attend school. You have a beloved older sister, a single mother of two young children, your nieces whom you adore.

One day, you get a phone call from your sister. She has cancer and not much time left. "Will you take care of my kids if... I don't make it?" Your shock, anger and grief quickly turn to how you will help your sister. As her illness progresses, you help her with everything from doctor's appointments to rent. You're overwhelmed and frightened.

Then you call The Family Center. Within days, one of our attorneys comes to meet with you and your sister in her hospital room. The attorney helps her execute a power of attorney, so you can address matters on her behalf. The attorney helps your sister execute guardianship papers for your nieces, who could soon be your responsibility. The housing case that arose when your sister couldn't pay her rent disappears after The Family Center attorney makes a phone call. Finally, our attorney helps your sister put her final wishes into a will. She dies within two weeks.

The attorney now connects you to a Family Center social worker who works with your nieces to deal with their grief. The Family Center also helps you access benefits to begin receiving much-needed financial support for the girls. At the same time, the attorney who sat at your sister's bedside now helps you finalize guardianship of your nieces. Somehow, you and the girls are forming a family out of this tragedy.

Our attorneys handle cases like this every day. Their work isn't easy, but provides a vital lifeline for the families and children we serve. Working across areas of family law, lifetime planning, housing and public benefits, their goal is always to serve clients on as many issues as possible. In our multidisciplinary approach, attorneys work hand in hand with social workers, a comprehensive model to address the complex problems faced by the families in our care. Family Center attorneys strive to achieve, not just successful resolutions, but enduring outcomes.

In 2010, our <u>Legal</u> Services Department closed 693 cases and secured \$841,000 in verdicts and settlements. Our attorneys logged more than 4,400 hours on these matters. This past year, the Department's work received a huge boost from volunteer collaborations, most notably from local area law schools and the Skadden Arps Honors Program in Legal Studies, based at CUNY. The Family Center is grateful to these community partners, and to the extraordinary commitment that our staff attorneys bring to the vulnerable families we serve.


