Our Vision

The Family Center envisions a future where all New Yorkers thrive in secure, healthy communities.



Our Mission

The Family Center provides holistic care and support to individuals and families affected by life-altering events to create a path to healing, stability and a fulfilling future.





PROGRAMMING:

Then & Now

Over the past 30 years, The Family Center has provided cutting-edge care and programs to underserved populations. As the needs of the community have changed, so have we. While our services have evolved

over the years, our core purpose has stayed true: to empower those experiencing crisis with the tools and resources they need to transform their lives.

Then

The Orphan Project: The Family Center's signature program through which we developed our multidisciplinary approach to HIV/AIDS services, bringing together case management, legal services, and social services.

Health Link: The Family Center became one of the only non-hospital grantees in the federal Ryan White Part D program focused on facilitating access to care for women of color living with HIV/AIDS and their minor children.

Early Support for Lifelong Success: The Family Center's parenting and early intervention program for young children and families affected by a parental diagnosis of HIV/AIDS, and often the child's exposure in-utero to the virus.

Brooklyn Women Enjoying Life: The Family Center's precursor to Healthy Branches was a recovery support program for women struggling with substance misuse.

Now

Legal Wellness Institute: Our legal team provides accessible, holistic civil legal services that meet the needs of low-income New Yorkers and families affected by serious illness and disability.

Caregiver Support Services: We provide supportive counseling, case management, advocacy, and groups/classes for families in which children are raised by someone other than their biological parents, often due to death, illness, incarceration, or abuse/neglect.

Healthy Branches: This Family Center Certified Community Behavioral Health Clinic serves low-income New Yorkers, including adults and children, with complex, severe, or co-occurring mental and behavioral health diagnoses, providing integrated services for mental/behavioral health, substance use, and primary medical care.

Irene LeeKong Health & Wellness Institute: Our NYS-licensed mental health clinic provides individual and group mental health treatment including psychiatric services for children and teens with mental and behavioral disorders that are less severe than those treated through Healthy Branches.

Training Institute: The Family Center has been designated a NYS Center of Expertise for HIV & Older Adults and a NYS Center of Expertise for Hepatitis C & HIV. We train service providers and peers across New York State.



METRICS: Then & Now

The Family Center has worked to achieve positive, sustainable outcomes for New Yorkers and their families for thirty years!

95%

of clients report improved daily functioning and/or the acquisition of new life skills after receiving services.



92% of clients report improved social connections after receiving services.

After 6 months of services, HIV-positive clients experienced lower viral loads and higher CD4 counts.



For clients, who are pre-diabetic or diabetic, TFC's services achieved statistically significant drops in A1C levels, as well as reductions in weight and waist circumference.



Healthy Branches achieved a **40% reduction in homelessness** and a 72% reduction in hospitalization rates, for clients in recovery.

Our child welfare-funded programs kept **99% of children** safe in their homes with their families.



Not one child receiving TFC services was placed in foster care for two years in a row, starting in 2022.

During the past 15 years, TFC attorneys served nearly **20,000 clients** over 34,000 of their family members.



TFC's LWI attorneys worked to create New York State's original standby guardianship law and then collaborated with legislators years later to expand the law to protect children whose parents are deported.



During our first 15 years, TFC attorneys served a total of **3,000 clients** and their families.

TFC's LWI attorneys work with client families that have a child with a developmental or intellectual disability to ensure these young people are cared for into their adulthood with special 17A guardianships in place.

“I AM HERE TO FIX MY LIFE.

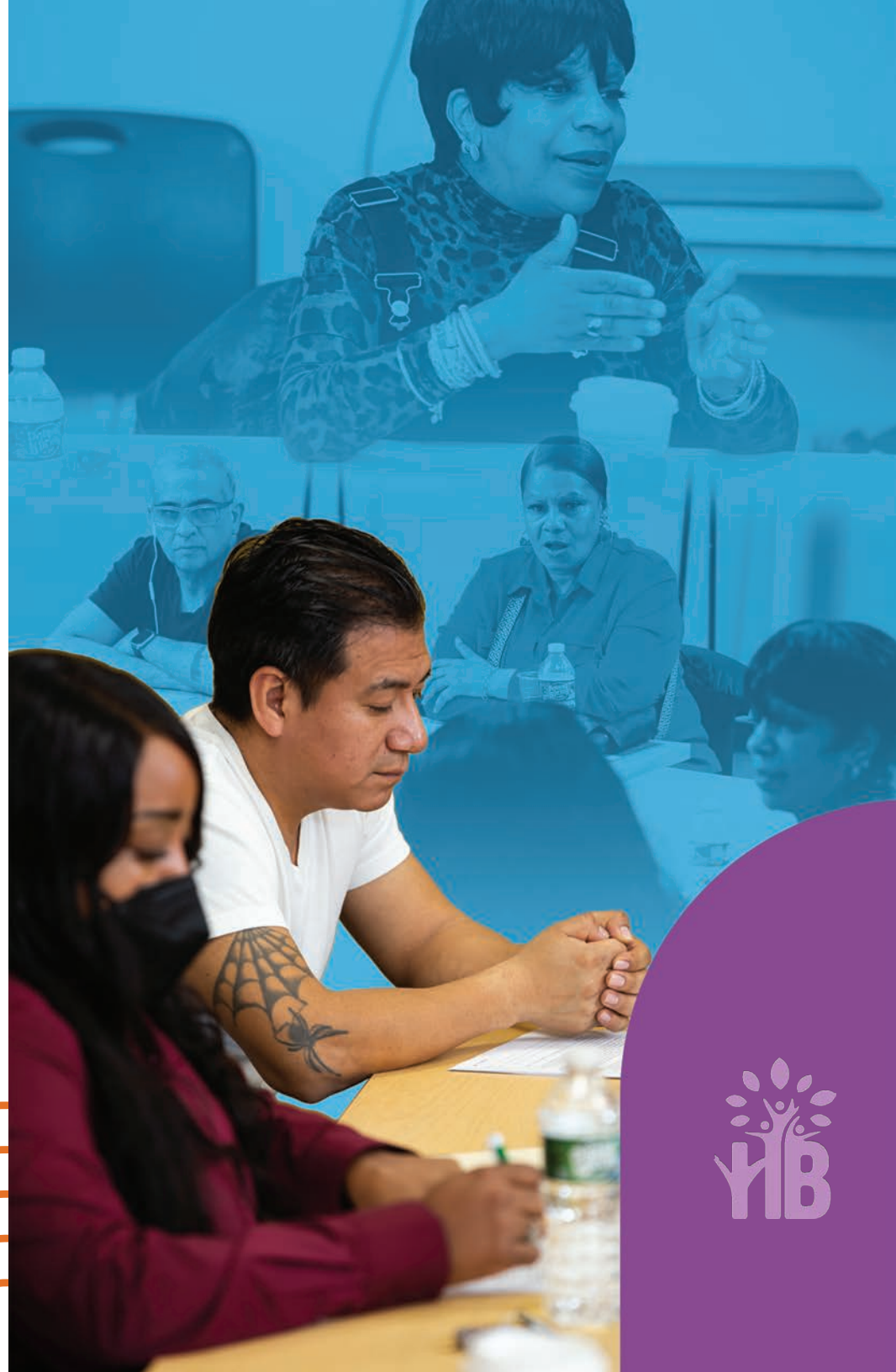

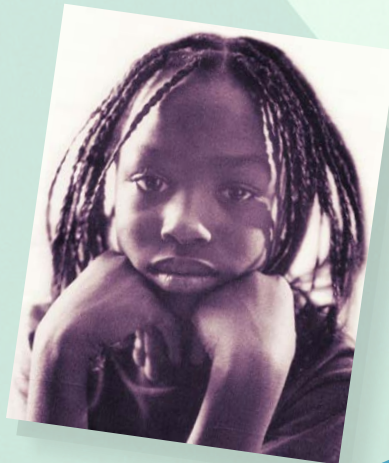
A CLIENT FAMILY, Thirty Years Later



"It was hard growing up," Christine said, "the kids at school would tease us."

Christine was raised by her grandmother Marilyn Moore, who is living with a life-threatening illness. Christine faced dual stigmas as a child: one, being raised by her grandmother, and two, her grandmother's diagnosis.

Marilyn raised not only Christine and her four siblings, but also her own five children. The Family Center enrolled the Moore Family in a group intervention



to support families impacted by a caregiver's life-threatening illness. *It went on to be adopted as a national model of care by the Centers for Disease Control and Prevention.*

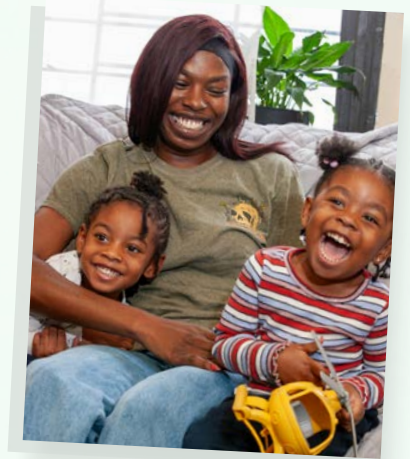
Recently, the Moore Family gathered at Marilyn's home in the Bronx to reminisce about their days working with The Family Center. Now a mother of two, Christine remembers learning to horseback ride and ski with Family Center volunteers. Marilyn's son, Ian, shared that a Family Center staffer gave him a Prince cassette tape, introducing him to the late performer's work.

Everyone shared the memory of The Family Center as a safe space for family members to communicate and learn.

"The Family Center gave us tools to speak our minds," stated Ian.

The Moore Family matriarch Marilyn had only a phrase to describe The Family Center.
